### RECOGNITION ORDER

Whereas, in terms of Section 15 of the NCTE Act, 1993, the LAKSHYA EDUCATIONAL AND SOCIAL WELFARE SOCIETY, PLOT NO.: 1079, STREET/ROAD: BAJRANG NAGAR, VILL.: GATHEWARA, P.O.: GATHEWARA, TEH./TAL.: CHHATARPUR, TOWN/CITY: CHHATARPUR, DIST.: CHHATARPUR – 471001, MADHYA PRADESH (Code No.APP3248), had submitted an application on 30.06.2015 to the Western Regional Committee of the NCTE for grant of recognition/permission to MAA SHARDA MAHAVIDHYALAYA, PLOT NO.: 1079, STREET/ROAD: 75, VILL.: GATHEWARA, P.O.: GATHEWARA, TEH./TAL.: CHHATARPUR; TOWN/CITY: CHHATARPUR, DIST.: CHHATARPUR – 471001, MADHYA PRADESH for B,A.B.ED. course of 4 years duration.

2. And whereas, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit, and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the WRC in its **326<sup>th</sup> meeting of WRC held on 22-23, January 2021** is satisfied that the institution/society fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the **B.A.B.ED.** programme, such as, infrastructural and instructional facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

3. Now therefore, in exercise of the powers vested under Section 15 (3) (a) of the NCTE Act, 1993 and in accordance with the clause 7 (16) of NCTE Regulations, 2014, <u>the Western Regional</u> <u>Committee, (NCTE) hereby grants Recognition for conducting B.A.B.ED. course. with an</u> <u>annual intake of 100 students (Two Units of 50 students each) from the academic session</u> <u>2021-2022 to MAA SHARDA MAHAVIDHYALAYA, PLOT NO.: 1079, STREET/ROAD: 75, VILL:</u> <u>GATHEWARA, P.O.: GATHEWARA, TEH./TAL.: CHHATARPUR, TOWN/CITY: CHHATARPUR,</u> <u>DIST.: CHHATARPUR – 471001, MADHYA PRADESH.</u>

4. The institution is required to ensure about the availability of the regular staff for teaching **B.A.B.ED.** courses.

5. The institution shall comply with various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

6. The institution shall make admissions only after it obtains affiliation from the examining body in term of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

7. The institution shall ensure that the required number of academic staff for conducting the course is always in position.

8. The recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, State Government etc. as applicable.

9. The Norms of staff qualification administrative and professional staff / terms and conditions of service etc shall be as per the provisions of NCTE Regulations 2014.

10. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with annual statement of accounts duly audited by a Chartered Accountant.

11. The institution shall maintain & update its website as per provisions of NCTE Regulations and always display the following as mandatory disclosure: -

The Educational Institution shall follow Uniform Accounting System as brought out by ICAI and 13. accepted by MHRD.

The institution shall fill the GIS Application within one month of issue of this order. 14.

If the institution contravenes the provision of the NCTE Act, Rules, Regulations and Orders made 15. and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provision of Section 17 of the NCTE Act, 1993.

Further, if the institution is not satisfied with the order, it may prefer an appeal under Section 16. 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of this order. The guidelines for filing appeal may be seen on NCTE's website.
